Overall Progress Narrative:

This is Volusia Countyâ¿¿s 2024 Quarter 4 quarterly performance report (QPR) for Community Development Block Grant â¿¿ Disaster Recovery (CDBG-DR) funding allocated through Federal Register 88 FR 32046, which was published May 18, 2023. This QPR will summarize the progress of Volusia County Florida CDBG-DR Program between October 1 to December 3 2024. The Countyâcis efforts reflect a grant received from the Department of Housing and Urban Development (HUD) to rebuild Volusia County from the damage caused by the September 2022 Hurricane Ian (DR-4673).

This guarter Volusia County made progress in many of its programs:

• The Homeowner Single Family Repair Program continued to progress on many fronts. The application process is still open to impacted homeowners. Over the past quarter, 132 new applications for assistance were received, bringing the total applications to over 1,450 of those, 642 remain active. The program began construction last quarter and achieved eight (8) construction completions this quarter.

• The Rental Repair Program received ten (10) applications. After careful review, three (3) were found to be ineligible, three (3) applications were withdrawn, and four (4) clients discontinued contact with our project coordinator. Given the lack of response, this program is scheduled to be closed and will be proposed to be removed from the Action Plan through a substantial amendment.

County Council approved eighteen (18) Infrastructure and Mitigation projects from seven (7) different municipalities and county government. CDBG-DR funds in the amount of \$60,765,603 were approved for these projects, with the various agencies leveraging \$48,079,152 of additional funding. The projects are now entering the environmental review and procurement phase. Approval was also given to fund twenty-eight (28) stormwater studies for ten (10) different municipalities and the county.

• The Multifamily New Construction Program received six (6) applications from developers with four (4) deemed complete and accurate to move forward for County Council consideration. Of the four (4), two (2) projects are focused on assisted senior living while the other two (2) are traditional multifamily housing facilities. The four projects would provide a total of 260 units, 136 for seniors, and 40 units would be direct replacement of Hurricane Ian damaged units. The projects will be presented to the Volusia County Council next quarter.

Community outreach efforts continued to be conducted during this reporting period, as well as one on one application assistance. The program sent approximately 21,000 postcard mailers to potential applicants identified from FEMA data and canvassed heavily impacted neighborhoods with doorhangers to solicit additional applications for the Homeowner Single Family Repair Program and had additional staff available at a library in the same proximity of the canvasing to assist with applications and questions.

As of December 31, 2024, more than 1,450 applications have been received for this program with intake of new applications still on going. Of those applications received, 642 remain active in the program. The applications received are being reviewed for eligibility and duplication of benefits as part of the intake process. In order to assist the most vulnerable populations with this disaster recovery funding, the County is prioritizing assistance to applicants based on a 1-8 prioritization matrix. The categories are based on the applicant's household income, whether any members of the household are age dependent (65 and older or 17 and younger), or whether anyone within the household is disabled. The program continues to process applicants through the eligibility phase and the assessments phase this reporting period.

Activity Description:

Hurricane Ian caused extensive damage to housing in Volusia County, greatly reducing the quality and safety of much of the impacted area's housing stock. To address damage to housing, Volusia County has developed the Homeowner Single Family Repair and Replacement program.

Volusia County proposes the following housing assistance activities under this program:

• Repair or replacement of single-family housing units (no more than four attached units) damaged by Hurricane Ian, which may include bringing the home into code compliance, and the incorporation of mitigation measures, including elevation, to help protect against future storm impacts;

• Replacement of, manufactured, modular and mobile homes impacted by Hurricane lan;

• Housing buyouts with incentives for eligible applicants in the SFHA when it is determined to be in the best interest of the applicant and the program to pursue this option; and

• Temporary housing assistance based on individual homeowner needs.

Volusia County will manage and complete the construction process for the repair or replacement of damaged homes on behalf of eligible applicants. With the assistance of an implementation vendor, the county will work with a pool of qualified contractors assigned to repair or replace damaged properties; applicants will not select their own contractors. The program will pay the vendor directly and no funds will be paid to homeowners. Applicants will be required to enter into agreements with the county setting forth the terms and conditions of the program.

Volusia County is aware of private not-for-profit entities who leverage private sector resources to work with impacted homeowners and provide short-term bridge loans to repair damage to impacted homes. These



organizations are familiar with CDBG-DR regulations and cross-cutting requirements (such as duplication of benefits and environmental regulations) and can provide assistance to help homeowners remain in their home and complete repairs quickly. Homeowners who choose to work with these entities may be eligible for reimbursement of their short-term bridge loans through the Single Family Repair and Replacement Program. Homeowners seeking this option must complete all construction before applying for reimbursement from the program. Due to federal requirements, the last day to apply for reimbursement will be May 23, 2024. Applicants may not initiate any further repairs on the damaged property after submission of an application for assistance from Volusia County. An applicant undertaking or completing any repairs after applying for assistance from the county may result in ineligibility for assistance through the Single Family Repair and Replacement Program. The Homeowner Single Family Repair and Replacement Program will not serve applicants seeking assistance for second homes. The home must be the applicant's primary residence.

Activity Description:

Hurricane lan caused extensive damage to housing in Volusia County, greatly reducing the quality and safety of much of the impacted area's housing stock. To address damage to the rental housing stock, Volusia County has developed the Rental Repair Program. The program is designed to provide repair assistance to eligible property owners in Volusia County for disaster impacted rental properties that meet the HUD definition of single-family structures (less than 5 attached units). Volusia County will manage and complete the construction process for the repair of rental homes on behalf of eligible applicants. With the assistance of an implementation vendor, the county will work with a pool of qualified contractors assigned to repair or replace damaged properties; applicants will not select their own contractors. The program will pay the vendor directly and no funds will be paid to landlords. Applicants will be required to enter into agreements with the county setting forth the terms and conditions of the program.

Landlords served through the Rental Repair Program will control and provide affordable rent in accordance with HUD guidelines for a period of 20 years. The affordability requirement states that property owner must lease the units to LMI households earning 80 percent or less of the AMI and must lease the units at an affordable rent. Rent must comply with the maximum HUD HOME rent limits. The maximum HUD HOME rent limits are the lesser of:

The fair market rent for existing housing for comparable units in the area as established by HUD under 24 CFR 888.111; or
A rent that does not exceed 30 percent of the adjusted income of a family whose annual income equals 65 percent of the

AMI, as determined by HUD, with adjustments for number of bedrooms in the unit. The HUD HOME rent limits will include average occupancy per unit and adjusted income assumptions.

Affordability restrictions will be enforceable by deed restrictions, covenants, or other similar mechanisms and/or



instruments.

Activity Description:

Hurricane Ian caused extensive damage to housing in Volusia County, greatly reducing the quality and safety of much of the impacted area's housing stock. To address the loss of housing stock as a result of the hurricane, Volusia County has developed the Multifamily New Construction Program.

The Multifamily New Construction Program is designed to serve as leveraged funding for larger multifamily projects. Projects funded through the Multifamily New Construction Program must provide affordable rent in accordance with HUD guidelines for a minimum period of 30 years. The affordability requirement states that property owner must lease the units to LMI households earning 80 percent or less of the AMI and must lease the units at an affordable rent. Rent must comply with the maximum HUD HOME rent limits. The maximum HUD HOME rent limits are the lesser of:

• The fair market rent for existing housing for comparable units in the area as established by HUD under 24 CFR 888.111; or

• A rent that does not exceed 30 percent of the adjusted income of a family whose annual income equals 65 percent of the AMI, as determined by HUD, with adjustments for number of bedrooms in the unit. The HUD HOME rent limits will include average occupancy per unit and adjusted income assumptions.

Affordability restrictions will be enforceable by deed restrictions, covenants, or other similar mechanisms and/or instruments.

The Multifamily New Construction Program received 6 applications from developers with 4 being chosen to move forward for County Council consideration. Of the four, two projects are focused on assisted senior living while the other two are traditional multifamily housing facilities. The four projects would provide a total of 260 units, 136 for seniors, and 40 units would be direct replacement of Hurricane Ian damaged units. These projects will be presented to the Volusia County Council next quarter.

Activity Description:
